Former Chief Justice of India

03-02-1964 till 15-03-1966

Closely connected with Indian Law Institute, New Delhi; Indian Institute of Public Administration, New Delhi; Indian School of International Studies, New Delhi, Indian Society of International Law, New Delhi; Humanist Union, Nainital; Youth Hostels Association of India, New Delhi; General Education Society, Bombay; Shikshan Prasarak Mandali, Poona ; India International Centre, New Delhi and many other educational and social institutions.
