“LET US REVISIT OUR JUSTICE DELIVERY SYSTEM”

1. Our concern is about our justice delivery system. ‘Injustice’ in ‘Justice’ is our bigger concern. Procedures being not respected fully, makes the concern intensified.
2. Court time management is becoming a foremost concern. It appears that Law Schools and Judicial Academies have to attend to this deficiency aspect of our Justice Delivery System. Not only the Court Time Management is to be approached as a distinct Discipline and to be included in Law Curriculum. But also, the same is to be made the mandatory Proficiency Skill by the Judicial Academies as well.
3. If it be made a Case Study of the existing state of ‘Court Time Management’, then we may gauge the depth to which the decline has reached. However, even the surface level impressions emerging from the Daily Cause Lists being made public, one is bound to get alarmed by the state of affairs.
4. Which matter and what stage of Trial deserve howmuch slot of time, is the aspect, which is missing from the listed Cause Lists, The way, the Court Time is spent in practice is bound to cause a shock for sensitive Judicial Conscious. But it appears that silently the poison of insensitivity is over shadowing even the Cognitive Faculty as well. From constitutional provision of ‘continuous super intendance and control’ to the legal mandate of ‘courts to be open’ there is a range of big parameters but still when procedures not getting respect then it deserves a question which need to faced, would be that ‘from where to begin’?
5. The natural and obvious option would be that the presiding officers of courts shall be put on introspective self evaluating mode. But will that be full answer for the expected needs of the aim to be achieved as per the norms of court time management desirable for our justice delivery system.
6. One is to be through the Discipline of court time management, not only academically but in practice as well, to preside the judicial court.
7. Then, the question would arise, as to whether we have explored well the pure and applied values of the Discipline of court time management and on their basis there stands settled academic and practice Programs for the presiding officers of the court and all the officers and officials of the court?
8. As, after all, beginning is to be had and as such let us begin without any further delay to plug court time mis management as the factor for ‘Injustice’ in ‘Justice’ being delivered by our system.
